New OISC Education and Outreach Grants

The Oregon Invasive Species Council (OISC) is excited to announce that \$150,000 in 2024-2025 biennium funds will be available to the OISC to fund education outreach project grants.

• Project budgets must be at least **\$5,000**. Projects over \$20,000 must show a collaborative, larger-scale watershed, community, or statewide education or outreach impact. Project scalability is desirable. Funding requests must align with the scale and reach of the projects.

• Grants will be awarded based on the availability of funds.

Who is eligible to apply? A grant applicant must be an eligible legal entity—a local or tribal government, non-profit organization, educational institution, or individual (an individual is not eligible for indirect or administrative costs).

Culvert AOP Grant Program

The Notice of Funding Opportunity for Years 2-5 of the <u>Culvert AOP grant program</u> was posted today to <u>grants.gov</u>. The program funds projects to replace and remediate culverts and weirs that are barriers to anadromous fish. Eligible recipients include State agencies, units of local government, and Tribes. Projects must have a transportation nexus. The deadline for Year 2 (FY 2023) applications is September 23rd, 2024.

Growing Equity Subaward Funding Opportunity

Oregon Department of Forestry, in cooperation with the United States Forest Service (USFS), has announced the Urban and Community Forestry (UCF) Subaward Program for All-Entities. This funding opportunity is designed to support programs and projects that promote the protection and enhancement of urban and community forest ecosystems in disadvantaged communities throughout the state of Oregon. Applications are open now through **October 15th**.

These programs will provide funding to eligible entities to advance:

- UCF planning and monitoring
- Nature-based education, recreation, and engagement
- Network development and relationship building
- Workforce diversification and development
- Nursery capacity building and tree production
- Tree planting and maintenance
- Adaptive management and lesson sharing throughout the state of Oregon

Applications are being accepted now through **October 15th**. There will be an additional funding opportunity opening in 2025.

Fall 2024 Open Solicitation Grant Offering - OWEB

OWEB is now accepting online applications for the the following grant types:

- <u>Restoration</u> (25% match is required)
- <u>Technical Assistance</u> (NEW: 5% match is required; no cap on requests)
- Engagement (NEW: 5% match is required)

Applicants are encouraged to consider the impacts of this year's extensive wildfires on native fish and wildlife habitat and watershed processes and to contact their regional program representative to discuss potential restoration projects in burned areas. OWEB anticipates making a combined total of over \$12 million available for Restoration, Technical Assistance, and Engagement grants through this solicitation.

Grant applications are due by 5 pm on Monday, October 28, 2024, and must be submitted via OWEB's online grant application. The OWEB Board plans to make grant awards at their April 2025meeting.

Partner Fund and Restore NW Grants

New Seasons Market, in partnership with Zero Foodprint, is kicking off the Restore NW Grant program to support a sustainable food economy. Hazardous Fuels Transportation Assistance

Up to \$25 million is anticipated to be awarded in 2024 through this opportunity to support projects that remove hazardous fuels from national forests and grasslands to a location where the materials may be used for various wood products and services.

USDA ANNOUNCES A FUNDING OPPORTUNITY TO SUPPORT INFLATION REDUCTION ACT GREENHOUSE GAS QUANTIFICATION EFFORTS

This funding opportunity is for a cooperative agreement to support model intercomparison studies.

USDA is announcing this <u>funding opportunity</u> for a cooperative agreement to support the coordination, implementation, and management of model intercomparison studies in agricultural systems. The model intercomparison study supports the <u>Inflation Reduction Act greenhouse gas quantification efforts</u>.

The purpose of the cooperative model intercomparison study is to assess and advance the state of science for carbon sequestration and greenhouse gas emission modeling for agriculture. Soil carbon sequestration and greenhouse gas emissions in cropland and grassland systems and their interactions with different climate-smart mitigation practices will be the focus of the study. The awardee will work with up to 8 independent modeling groups to implement the study.

Proposals from interested parties to lead the study are requested by October 4, 2024, for competitive consideration of the award with \$1.9 million total funding available for a 4-year agreement to support the study lead and up to 8 independent modeling groups. Eligibility is limited to institutions in the <u>Cooperative Ecosystem Studies Unit (CESU) network</u>.

DEQ Rulemaking – Willamette River Mainstem and Major Tributaries Temperature TMDL Replacement – DEQ is asking for Public Comment on the Proposed Rule Amendments

The DEQ is proposing to amend Oregon Administrative Rule 340-042-0090 related to Total Maximum Daily Loads (TMDLs). Consistent with Oregon Revised Statute 468B.110 and OAR chapter 340 division 42, this rulemaking proposes to develop temperature TMDLs for the mainstem Willamette River and all the major tributaries downstream of the dams, except for the McKenzie River which is included in the Subbasins TMDL. The TMDL and Water Quality Management Plan will be proposed for adoption by Oregon's Environmental Quality Commission, by reference, into OAR 340-042-0090. The U.S. Environmental Protection Agency will review the TMDL after the commission adopts the rule.

Farm Succession Workshops

Oregon Ag Trust is excited to announce a workshop this fall featuring long time Ag consultant Dick Wittman at the Ag Complex at Chemeketa Community College in Salem on **November 19th and 20th.**

- Day 1 is intended for farmers and ranchers but service providers are certainly encouraged to attend as well. This all day workshop will help farm & ranch business owners work through solutions to common family business management and succession challenges. Workshop participants will gain insight on professionalizing business management or governance practices as well as preventing and reducing conflict in the family business. The cost to attend is \$100 with lunch provided.
- 2. Day 2 is a full day ag consultant training course for service providers. This workshop will help service providers implement consulting tools to better serve farm and ranch businesses as they work through the estate and succession planning process. It's designed for service providers who are advising farm and ranch business owners on transition planning, assisting clients in their business management practices and looking for strategies to prevent and reduce conflict in the family business. The cost to attend is \$300 with lunch provided. We are in the process of applying for continuing education credits for accounting for this course. We have obtained approval for 6.25 hours of continuing legal education credits.

Program participants meet every week for virtual group sessions and work time, and meet 1-on-1 with Future Farms Program Director Geoffrey Van at least two times for individual personalized support. Through these group and individual sessions, we address questions and barriers that arise and take steps to build effective and sustainable business plans, as well as advance participants' farming goals. We'll explore topics including: visioning and goal setting, labor and employees, bookkeeping, land and capital access, products, marketing, sales, and so much more. Kim Peterson, long-time director at East Multnomah SWCD, recently passed away passed away peacefully on August 8, at the age of 74. Kim spent her entire life on Sauvie Island, where her family managed a 250-acre dairy farm during her upbringing. Over the years, the farm evolved into a beef operation and now includes grass, food crops, and duck lakes. Kim had a deep connection with the West Multnomah SWCD, following in the footsteps of her father, Elmer Peterson, who served as Treasurer for many years. Kim herself took on the role of Treasurer for a time and was a dedicated board member from November 1999 until her passing in August 2024– an incredible 25 years of service. In recognition of Kim and her family's longstanding dedication to the District, she was honored at the 2016 Annual Meeting with a special award and a video highlighting the Peterson family's significant contributions.

Josh Thompson, was involved in a tragic auto accident on August 21. Josh has worked for Wasco County SWCD for the past 24 years and his loss is deeply felt. This news comes as a shock and is difficult to process. There will be a Celebration of Life for Josh on Thursday, August 29th, at 2:00 pm at the Wasco County Fairgrounds in Tygh Valley, OR. Everyone is welcome to attend. Josh had a tremendous influence in so many ways and he will be greatly missed.

NOTICE OF 2024 OACD BOARD ELECTIONS

District Board Members and Management Staff:

We are now requesting nominations for OACD board positions. Please see the listing of positions below that are up for election. The term is for 3 years, serving until December, 2027.

Candidates may self-nominate by sending a statement of 150 words or less by 5:00 p.m. on **September 20** to OACD (andrea.kreiner@oacd.org) indicting why they want to serve and their qualifications in a brief bio of 150 words or less (see example at the end of this notice). Remember that both district board directors and management staff are both eligible to be elected. The bylaws require that management staff have their board send an email to OACD affirming the candidacy of their staff to assure that the district can support the necessary time commitment.

We will send out the list of candidates with their statements by **September 27** with a ballot. We are asking that each district complete the ballot and return it to OACD by **November 29**, allowing up to two board meetings for districts to vote based on their internal discussion. Each district can submit a ballot by mail or electronically representing the district's choices (one ballot per district). Director seats will be determined by the highest number of votes. We request that you send ballots back electronically and then confirmation of receipt of ballots will be provided. Ballots will be tallied and results available by **December 12**.

Following the election process, the new and existing board members will meet virtually at the OACD board meeting in **December** to elect officers and transact any business.

Positions:

- Northwest Oregon Region. The list of districts eligible for this position are: Benton, Clatsop, Columbia, Lincoln, Linn, Polk, Siuslaw, Tillamook, Upper Willamette, Yamhill.
- <u>Southern Oregon Region</u>. The list of districts eligible for that position are: Coos, Curry, Douglas, Ft. Rock – Silver Lake, Illinois Valley, Jackson, Klamath, Lakeview, Two Rivers, Umpqua.

Don't forget that <u>dues must be paid</u> for a candidate to be nominated from a district and for districts to submit a ballot in the election.
